Benefit highlights

- Outpatient mental health/substance abuse will follow PCP (not specialist) cost share.
- All plans include acupuncture. This benefit follows PCP cost share and allows up to 10 visits per calendar year.
- PCP and referrals are not required.
- Plan providers must be used to receive benefits. Outside network coverage is for emergencies only.
- Coverage is available at all MinuteClinic locations nationally.
- Coverage for all essential health benefits:
 - Ambulatory patient services
 - Emergency services
 - Hospitalization
 - Pregnancy, maternity and newborn care
 - Mental health and substance use disorder services, including behavioral health treatment
 - Prescription drugs
 - Rehabilitative and habilitative services
 - Laboratory services
 - Preventive and wellness services and chronic disease management
 - Pediatric services, including oral and vision care
